

 This provides a higher Level of protection from fluid splashes or sprays.
- Being a NIOSH approved respirator means the mask provides 95% filtration efficiency of 0.3 micron dry particles, but are not resistant to oil.
- Two strong polyurethane headbands fit the mask securely to the users face to help to ensure a tight facial fit and seal, preventing air leakage around the mask.
- Pouch-style provides a large breathing chamber with a SO SOFT* inner lining for added comfort.
- The mask uses Latex and DEHP-free materials reducing the likelihood of skin irritation and allergies.
- All HALYARD FLUIDSHIELD* N95 masks are CE marked as per 93/42/EEC Directive on Medical Devices.
